

# RULES OF PERSONAL DATA PROTECTION

- The Company Hacktrophy spol. s r. o., Záhradnícka 60, 821 08 Bratislava – city district Ružinov, Company ID No.: 50 767 895, registered in the commercial register of the District court Bratislava I, section Sro, file No. 118223/B (hereinafter only as the „**Hacktrophy**“) collects and processes personal data for the purpose further specified in these rules of personal data protection in the maximum range of: name, surname, address of permanent residence, e-mail address, telephone number, bank account number. The Company Hacktrophy will obtain mentioned personal data through registration, or otherwise as it is stated on the website <https://hacktrophy.com> (hereinafter only as the „**Website**“). Any collection and processing of personal data by Hacktrophy is carried out strictly in accordance with provisions of the Act No. 122/2013 Coll. on personal data protection and on the change and addition of some acts (hereinafter only as the „**act on personal data protection**“).
- Expression of your explicit consent with providing of your personal data needed for proper provision of the chosen service is the necessary condition of using of any services provided by Hacktrophy through the Website. Please be aware, that without providing of the requested personal data, Hacktrophy cannot provide you with its services.
- You grant your consent to Hacktrophy with using of your personal data according to conditions stated in these rules for the period of 10 years.
- By using the Website you agree, that your personal data obtained though registration or otherwise in connection with the use of the Website, can be transferred across international borders to places, where servers supporting the Website are located (including but not limited to transfers from these places back to the country of your registration) for the purpose of operation and development of the Website, including transfers to subcontractors or to representatives of Hacktrophy, who perform tasks connected with the Website, or for the purpose of the storage of data in respective databases.
- The purpose of personal data processing depends on the content of service provided by Hacktrophy, which you choose to use. Hacktrophy obtains personal data as described above for the following purposes:
  - a. use of the service/your active participation in the Hacktrophy Bug Bounty Program, whether as the customer or as the ethical hacker according to the conditions stated on the Website,

b. sending of business, marketing and advertising information, specifically:

With the use of statistical probability we are doing our best to present you only with such advertising contents, which are interesting for you, while we do it by sending of advertising information via e-mail. You can disagree with such use of your personal data anytime by short written notice to [info@hacktrophy.com](mailto:info@hacktrophy.com).

Thanks to our Newsletter, which we send via e-mail, you have the opportunity to obtain regularly the information on activities and offers of our company. You will receive our Newsletter only in case you grant us your explicit consent to do so. You can withdraw your consent with saving your e-mail address and its use for sending of the electronic Newsletter anytime without incurring any other costs than costs connected with sending of this information according to the basic tariffs. You can find the link for the Newsletter logoff at the end of every Newsletter.

We obtain your personal data also for the purpose of presentation of services provided by our company in the future, but also for the purpose of answering your possible questions, or comments to the range, content or quality of our services. We will use this data in accordance with effective legal acts for sending of answers to your questions, or to contact you via e-mail or by phone and to inform you about services or promotional events, which we offer. We can also need your personal data so that we could contact you to obtain additional information needed for processing or for fulfilment of your order and/or your request.

- Except when required by effective general legal acts, we will not submit your personal data to the third person without your consent.
- According to the sec. 28 par. 1 of the act on personal data protection you are entitled to request from us upon written application:
  - a. confirmation, whether your personal data are or are not being processed,
  - b. information about the state of processing of his personal data in the filing system in a generally intelligible form and in the extent under Section 15 Paragraph 1 Points a) to e) Numbers 1 to 6;
  - c. exact information, in a generally intelligible form, about the source from which the controller obtained his personal data for their processing
  - d. list of his personal data, in a generally intelligible form, which constitute the subject of the processing

- e. rectification or erasure of his inaccurate, incomplete or not updated personal data, which constitute the subject of the processing,
  - f. erasure of his personal data, if the purpose of their processing was fulfilled,
  - g. erasure of his personal data which constitute the subject of processing if there was a violation of the law,
  - h. blocking of his personal data due to the cancelation of the consent for personal data processing before its expiration if controller processes personal data based on the consent
  - i. of the data subject.
- The Company Hacktrophy will complete, correct or erasure any incomplete, inaccurate or not updated personal data obtained by Hacktrophy in connection with the Website operation, on our own initiative or at your request.
  - You can use the Website for information purposes without having Hacktrophy informed who you are and providing any personal data. However from time to time Hactrophy or authorized third persons can placed into your computer information, which enables to collect some data to Hacktrophy. These information are generally known as "cookies" and are used on many websites. Cookie is saved on hard disk in your computer, not on the Website. Hacktrophy and/or entitled third persons will only use information, which they placed in cookies on their own through the Website.

Using of cookies brings you benefits, as for example it eliminates the need for frequent password input during one visit. This information is not personally identifiable - in other words, cookies identify your computer, not you personally. If you do not wish to receive cookies or want to be notified of their reception, you can set up your internet browser if this browser allows you to do so. Please note that when cookies are turned off, you may not always be able to view certain parts of the Website that would enrich your visit or you will not be able to download certain content and/or participate in certain transactions on the Website.

In addition, the Website may also use another technology that allows Hacktrophy to collect certain technical information, such as your Internet Protocol (IP) address, the type of operating system you use on your computer, the type of Internet browser and the addresses of other linked sites to improve the provided services.

- A person under the age of 18 years, respectively person younger than the recommended or statutory limit in certain country, may not send to Hacktrophy any information. In case you are younger or minor, you will need for using of the

Website and services, or for realization of any legal acts consent of your parent(s) or your legal representative(s), except when such activities are permitted in the country of the applicable law.

- We are entitled to change, edit these rules of personal data protection or prevent from access to the Website or its content, anytime and without previous notice.
- Hacktrophy is entitled to establish separate conditions for various provided services, in which it is entitled to adjust specific conditions concerning given service (including protection of privacy and data).
